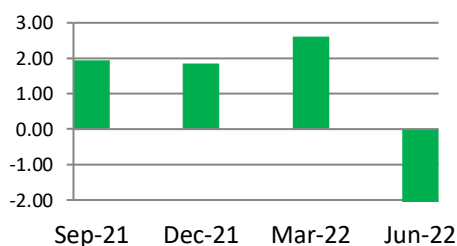

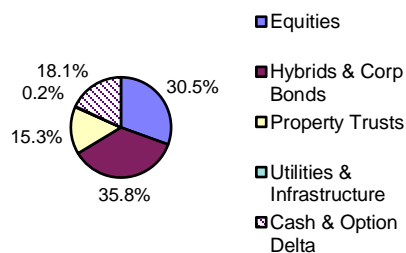
Investment Objective

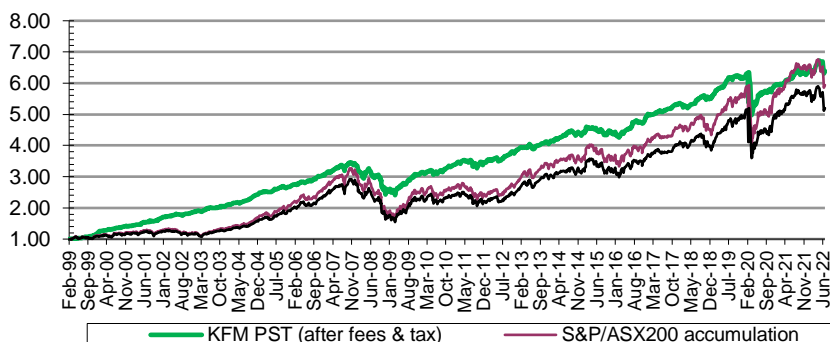
